The relationship between religious identity, religiosity and behavioral polarization in the United States, international religious freedom issues, how religious dynamics influence political institutions and outcomes, and how mixed methods research designs can understand the complex relationship between religion and politics

"Belief or Belonging? Evangelical Religiosity and Its Impact on Affective Polarization"

My doctoral dissertation untangles and unpacks distinct aspects of evangelical religiosity and if these specific forms affect the high levels of affective polarization among American evangelicals. Identifying who evangelicals are through simple self-identification schemes obscures who this increasingly powerful group is in American politics. While recent work has done a better job in classifying them, work remains to be done not only to determine what comprises evangelical religiosity, but how these patterns of belonging and specific beliefs influence higher than normal feelings of antipathy towards the outgroup. By disaggregating religiosity into both belief and belonging, this research shows how these discrete aspects of evangelical religiosity influence the way American evangelicals behave and operate in the political sphere. Through a systematic historical analysis and novel survey data, I find evidence that evangelical belonging produces high levels of "bonding" forms of social capital, which in

turn leads to high levels of in-group trust and solidarity as well as mistrust and dislike towards the out-group, or in other words, affective polarization.
